Entries close 6:00 PM PDT WEDNESDAY, OCTOBER 18, 2023, at the address designated for event processing, after which time no entries may be accepted, canceled, changed, substituted, corrected, completed or signed and no entry fees refunded. Any changes and cancellations must be received in writing prior to closing date, except as provided the change of the AVC Dec Show Bulgo. for in Chapter 11 Section 6 of the AKC Dog Show Rules.

Canadian exhibitors must submit entries with checks drawn on U.S. accounts or with international money orders in U.S. funds. Returned checks and invalid or declined credit cards do not constitute a valid entry fee. Returned checks and invalid or declined credit cards must be made good before the dog(s) will be allowed in the ring. Any person that issues a check that is returned for non-payment, or submits payment by credit card that is declined, will be required to pay a fee of \$25 in addition to the entry fees for which check or checks were issued or for charges to the declined credit card. The entry fee plus the \$25 shall then be paid by cash, money order, or cashier's check. Subsequent returned checks or declined credit cards from the same exhibitor may result in their being put on a cash only basis.

Conditional, unsigned, incomplete or entries received without correct fee amounts will not **be accepted.** Owners are responsible for errors on entry blanks including wrong information, entering a dog in a class in which the dog is not eligible to compete or for entering the same dog

Entries not on official AKC forms or downloaded or photocopies of entry forms without rules and agreement on reverse side of Official AKC entry form and/or not within the official AKC entry size are NOT acceptable.

Parking

Sycamore Lane Kennels & Farm and All Dogs Sports Park provides parking for your event participants and spectators (\$5/vehicle). We ask you to abide by a few simple rules:

- ▶ Do not park near or around the kennel or groom shop.
- ▶ Parking is not allowed around the pond or between the lawn and the pool. These are designated fire lanes. Vehicles will be towed at owner's expense and could be subject to a fine.
- ▶ Parking is **NOT** allowed in the lot adjacent to the lawn, bordered by the training building, the exercise yard and the duplex. Parking is to the east of the pond lawn.
- ➤ The dirt area between the pool and the vineyard is reserved for the event coordinators and volunteers.

Grounds

- ► THE YARDS MARKED "KENNEL PERSONNEL ONLY" MEANS JUST THAT. PLEASE DO NOT USE THESE YARDS.
- ▶ PLEASE DO NOT LET YOUR DOGS POTTY ON THE LAWN BY THE POND, IN THE PLANTERS AROUND THE POND, IN OR CLOSE TO THE VINEYARD. THE DIRT AREA IS FINE AND THE POTTY RUNS BEHIND THE POOL ARE ALSO FOR YOUR USE.
- ▶ USE THE POTTY YARDS BEHIND THE POOL, THE DIRT (BUT NOT IN THE GRAPES) OR THE CIRCLE OF GRASS TO THE EAST OF THE POOL IN THE RV PARKING LOT.
- ▶ WE PROVIDE POOPER SCOOPERS AND DISPOSAL BUCK-ETS. PLEASE PICK UP AFTER YOUR DOG.
- ► ALL DOGS MUST STAY A MINIMUM OF 5 FEET APART, UNLESS FROM THE SAME FAMILY.
- ► NO RETRACTABLE LEASHES (I.E. FLEXI).
- ► X-PENS AND CRATES MUST HAVE BOTTOMS IF YOU ARE PLACING THEM ON THE LAWN OR IN THE ARENA (No X-pen set up in the arena). IF YOU LEAVE THEM ON THE LAWN OVERNIGHT, PLEASE TIP THEM ON END.
- ▶ PLEASE DO NOT TAKE YOUR DOGS INTO THE HUMAN BATH-ROOMS.
- ► THE LANE IS FOR EXERCISING KENNEL DOGS, SOME OF WHOM ARE NOT FRIENDLY. PLEASE STAY AWAY FROM THIS AREA.
- ► UNLESS THE POOL IS PART OF YOUR LEASE OR YOU SIGNED UP FOR OPEN DOCK, IT IS OFF LIMITS.

RESERVED OVERNIGHT PARKING INFORMATION

Amateur Owner Handler Bitches

(Effective as of 1/1/2009) Chapter 3, Section 7 of the AKC Rules Applying to Dog Shows "The Amateur-Owner-Handler class shall be for dogs that are at least six months of age that are not champions. Dogs must be handled in the class by the registered owner of the dog. This class is restricted to exhibitors who have not, at any point in time, been a professional dog handler, AKC approved conformation judge, or employed as an assistant to a professional handler. Additionally, members of the immediate family or household of a current professional handler are ineligible for this class (as defined in Chapter 11, Section 13)."

Bred By Exhibitor Dogs Bred By Exhibitor Bitches
All dogs entered in the Bred-By Exhibitor Class must be individually registered with the AKC. The person handling the dog must be a breeder of record of the dog and an owner of record of the dog. To exhibit in this class, family members must be a breeder and owner of record

AWARD OF MERIT At the Judge's discretion, no more than 5 deserving Dogs or Bitches, in the Ring for Best of Breed, may receive an Award of Merit. It is not mandatory that the judge award any certificates. Each Judge of Intersex will be given the criteria for such awards. Dogs awarded Best of Breed, Best of Opposite Sex to Best of Breed and Best of Winners are excluded from selection by virtue of their higher placement. The Award of Merit shall be given following Best of Breed, Best of Winners, Best of Opposite, Select Dog, and Select Bitch.

Best of Breed Competition

Grand Champion Select points offered at judge's discretion

Best Puppy Competition

From the Puppy Class first place winners (BCNC AM Sunday Show Only)

Best Bred by Exhibitor Competition (BCNC PM Sunday Show Only)

NON-REGULAR CLASSES INVOLVING SINGLE DOG ENTRIES - ALL SHOWS

Winners of these classes, if otherwise undefeated, compete in Best of Breed Competition,

*VETERAN DOG AND *VETERAN BITCH CLASS - For Dogs and Bitches 6 (SIX) years of age and older. Open to Champions and Non-Champions alike. A dog may be entered in the Veterans Class without being entered in any other class. Dogs & Bitches will be judged separately.

*Chapter 11, Section 8 of the "Rules Applying to Dog Shows" provides that a neutered male may be entered as a Veteran Dog in the Veteran Dog Class and a spayed bitch may be entered as a Veteran Bitch in the Veteran Bitch Class.

NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

As the judge's decision in these classes is based on the merits of more than one dog, none of the dogs judged first in the class will be eligible for Best of Breed Competition by virtue of having won this class.

*STUD DOG CLASS - Stud Dogs shall consist of 2 get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their get. While the merits of the stud dog are not to be considered in placement of the entry, the stud dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC Policy or the Standard for its breed. Get must be entered individually in a Regular Class. Best of Breed or some other Non-Regular class of the same show. Get only to be judged. (Neutered Stud Dogs may be entered).

*BROOD BITCH CLASS - Same as for the Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get. (Spayed Brood Bitches may be entered).

*Chapter 11, Section 8 of the "Rules Applying to Dog Shows" provides that a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class.

The following classifications are not offered:

Bred by Exhibitor Puppy, Novice Classes, Brace

Novice Class - For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or

Open Class - For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

Master Class - This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

Each dog handled in a Junior Showmanship Class must be entered in one of the Breed or Obedience Classes at the show, or must be entered for Junior Showmanship only. However, a dog may be substituted. Such substitution must be accompanied by an official AKC entry form. All such substitutions must be made one half-hour prior to the judging of any Junior Showmanship Classes at the show. Each dog must be owned or co-owned by the Junior Handler or by the Junior Handler's father, mother, brother, sister, uncle, aunt, grandfather or grandmother, including step and half relations or by a member of the Junior Handler's household. Every dog entered for Junior Showmanship must be objected for the Junior Showmanship must be obje entered for Junior Showmanship must be eligible to compete in Dog Shows or in Obedience Trials.

BITCHES IN SEASON ARE NOT ELIGIBLE. A dog that has been excused or disqualified by a Breed Judge or by a Bench Show Committee may still be handled in Junior Showmanship if eligible to compete in Obedience Trials. IMPORTANT INFORMATION RELATING TO COVID-19

Mother Lode Bulldog Club of Sacramento and Bulldog Club of Northern California (the "Clubs") will prioritize the health and safety of their members, exhibitors and others in attendance at these specialty shows. As such, the Clubs will enforce social distancing rules and other guidelines implemented by the Governor of California, the State Department of Public Health or other state or local government agencies in response to the Covid-19 pandemic and in force at the time of our shows. These Public Health Guidelines are subject to change at any time and could, under extreme circumstances, reguire the cancellation of our shows for reasons beyond the Clubs' control. The Clubs will take actions to mitigate health risks to the best of their ability. The Clubs are pleased to be able to hold our specialty shows OUTDOORS under a very large outdoor area (approx. 20,000 sq. ft.) which will facilitate safe social distancing for exhibitors, spectators, members and our judges. Other precautions may be taken to adhere to Public Health Guidelines, including limiting the number of chairs around the show ring and requesting that attendees try to stay at least 6 ft. apart where possible. Those in attendance will be expected to wear a face covering while in the ring and at any other time they are in the arena and may be in close contact with others outside their immediate family.

The Clubs will ask our judges to allow extra time for exhibitors and their dogs to reach the ring, if necessary, to avoid crowding at ringside. The Clubs will adjust their schedule of events as necessary in response to the public health conditions in place at the time of our shows. There can be no assurance that this will change before the time of our shows. No matter what, it's our intention that everyone enjoy themselves, stay safe and make the best of it in these challenging times. While the Clubs do not, at this time, intend to restrict attendance at the shows, please be mindful of the Public Health Guidelines before you invite friends or other members of the public to attend.

Everyone entering their dogs at these specialty shows and attending the event for any reason is aware of, and accepts, any public health risks that may exist at the time and is fully responsible for the consequences of their own actions. Although the Clubs intend to follow Public Health Guidelines, they accept no responsibility, financial or otherwise, for loss, damage or injury that may occur as a result of anyone's participation of any kind in these shows.

If it should become necessary for the Clubs to cancel these shows for any reason, prior to the closing date for entries, any entry fees received will be refunded in full in a timely manner to the person that made such entries and in the form he or she made them. If the show must be cancelled after close of entries, the Clubs will retain that portion of the entry fees that are needed to offset unavoidable costs of the show and intends to refund the balance. - The exhibitor will be immediately suspended from participating in all AKC Events and the offender's name(s) shall be published in the AKC Gazette and The Bulldogger as having been found guilty in violation of said AKC/Host Club rules.

BULLDOGS ARE EXPECTED TO BE JUDGED ON A RAMP. NO DOG WILL BE ALLOWED IN THE SHOW AREA EXCEPT THOSE ENTERED IN THE SHOW. NO PUPPIES UNDER FOUR MONTHS OF AGE ARE ALLOWED AT THE SHOW SITE. NO DOGS OR PUPPIES ARE TO BE SOLD AT THE SHOW SITE.

- 1. Entries must be submitted on an American Kennel Club (AKC) Official Entry Form or exact copy (both front & back) and must be signed. Owners are responsible for errors on entry blanks. The Club and/or its Event Secretary assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or owner's Agent entering a dog or a class for which the dog is not eligible to compete. Conditional entries are not accepted.
- 2. Exhibitors are advised to make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this premium list. Rule books are available from the Event Secretary or may be obtained from the AKC.
- 3.
