This will be done after Best of Breed judging unless the Best Puppy award is automatic. Example: An entry from the puppy classes is awarded Best of Winners or Best of Breed. Only dogs/bitches undefeated in the puppy classes are eligible for Best Puppy competition. If the first place winner is not present, the second place winner may not compete.

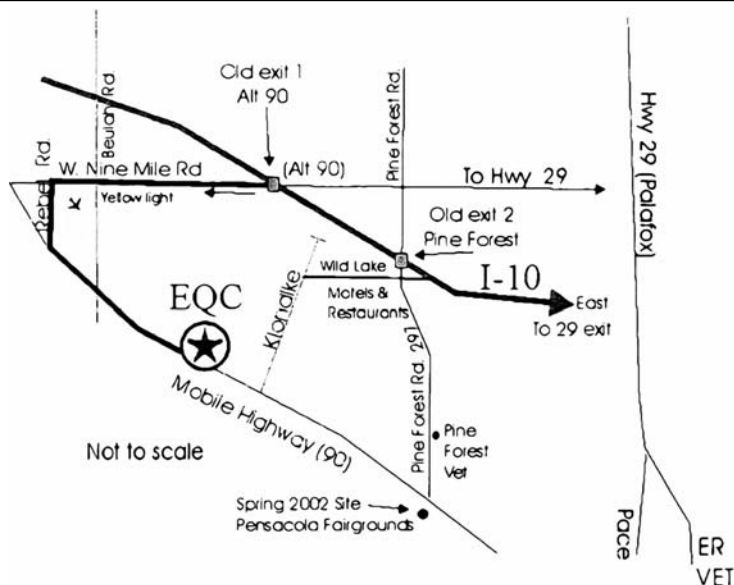

Fax entries that are received incomplete or unable to be read will not be accepted. The proof of transmission is not proof for verifying faxed entries. Telephone and emailed entries are not accepted.

Canadian exhibitors must submit entries with checks drawn on U.S. accounts or with international money orders in U.S. funds. Returned checks and invalid or declined credit cards do not constitute a valid entry fee. Returned checks and invalid or declined credit cards must be made good before the dog (s) will be allowed in the ring. Any person that issues a check that is returned for non-payment, or submits payment by credit card that is declined, will be required to pay a fine of \$25 in addition to the entry fees for which check or checks were issued or for charges to the declined credit card. The entry fee plus the \$25 shall then be paid by cash, money order, or cashier's check. Subsequent returned checks or declined credit cards from the same exhibitor may result in their being put on a cash only basis.

Conditional, unsigned, incomplete or entries received without correct fee amounts will not be accepted. Owners are responsible for errors on entry blanks including wrong information, entering a dog in a class in which the dog is not eligible to compete or for entering the same dog twice.

Entries not on official AKC forms or downloaded or photocopies of entry forms without rules and agreement on reverse side of Official AKC entry form and/or not within the official AKC entry size are NOT acceptable.

- (Variety) If you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

ATTENTION EXHIBITORS

The Show Site will be available to exhibitors at 2:00 pm Friday, February 27, 2015. Grounds closed to entry until that time. Dogs must be removed from the show site immediately following Best in Show judging on Sunday, March 1, 2015.

The club reserves the right to substitute one trophy for another of equal or greater value. All trophies not claimed the day of the show become the property of the show-giving club.

Unentered dogs will not be allowed in the arena, grooming or vendor areas at these shows. All dogs must be kept on leash when not crated or in exercise pens. Parents will be responsible for the actions of their children and their conduct both in and outside the Exhibition Center. Show/Center will not be responsible for any injury. No baby strollers will be allowed in the exhibition area. Arena seating available. No Firearms or illegal drugs on the show grounds.

All cell phones, pagers and other electronic equipment must be turned off while at ringside and while in ring.

Selling dogs will not be permitted on the show grounds.

Grooming and crating will be in designated areas only and will be strictly enforced. No dogs or crates allowed in restrooms or bleacher areas. Exhibitors are requested NOT to permit their dogs to urinate on walls, pillars or equipment in the Exhibition Center. No exercise pens allowed in the arena or directly adjacent to pedestrian pathways. **SOFT-SIDED CRATES ARE ALLOWED IN THE GROOMING AREA. DOGS IN SOFT-SIDED CRATES MUST BE MONITORED, SECURED AND NOT AGGRESSIVE.**

Crates and small toy grooming stands allowed ringside during their breed judging MUST BE REMOVED immediately following judging. Crates left unattended after breed judging may be removed by Show Committee members. Dogs cannot be left crated in arena or corridors after Best in Show and will be removed. **DOGS MUST BE PRESENT WHEN CALLED FOR JUDGING.**

SHOW COMMITTEE WILL BE CALLED FOR ANYONE LEAVING DOG EXCREMENT ON SHOW GROUNDS OR MOTEL PROPERTY. Any and all damages caused by the exhibitor will be the sole responsibility of the exhibitor. **NO SMOKING in Arena or Stall areas due to fire hazard.**

Exhibitors must keep grooming area clean. Crates must be stacked to maximize space available for setups. Crates blocking traffic will be removed. At owner's risk, those exhibitors renting stalls may leave dogs in the stalls overnight. Exhibitors need to bring their own locks and chains to secure stalls. Neither the Escambia County Equestrian Center, the Superintendent, Event Secretary nor the show giving clubs will be responsible for any dogs or equipment. All owners/agents will leave equipment at their own risk.

Showers and bathrooms will be open. No bathing of dogs in front of stalls or in showers - please use designated wash bays. Two bays have hot water.

The only electrical outlets available are at RV sites, in stalls rented by the Escambia County Equestrian Center or on poles in the arena, where the Equestrian Center Charges \$17.00 per day. Stalls are 12 feet x 12 feet and have two (2) outlets. They have sliding, lockable doors for security and can be reserved for \$17.00 per day, \$28.00 for 2 days or \$39.00 for 3 days. Some stalls will be reserved for those who wish to share.

Shavings can be purchased for \$7.00 from the Escambia County Equestrian Center or you may wish to use a tarp on clean, packed dirt floor of stall. If you wish to purchase a drop cloth through the club, contact: sumac@netzero.net - please state in subject line. PDFa will purchase and provide.

Dump station fees are \$10.00. **Overnight fee for free standing parking is \$10.00.** Fee payment must accompany all reservation forms.

WAIVER OF RIGHTS

The FL-AL Toy Breeds Club reserves the right to remove any animal in distress from a parked vehicle or crate. All persons attending this show hereby waive any claim for damages against the club for such removal. Event Secretary and Event Committee have authority to change rules for the safety and comfort of dogs and exhibitors. The Show Committee, in accordance with AKC Rules and Regulations, will deal with violations in this area. This club does not agree to arbitrate claims as set forth on the Official AKC entry form.
