

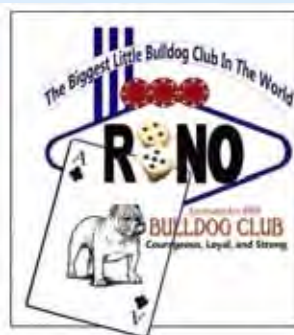

Routes to the Events

From North on 395 S

Hwy. 395 South through Carson City. Take first right (one block, at light) after intersection with Hwy. 50 West (Lake Tahoe Exit) onto Clear Creek Rd. A two block distance will bring you to the park across from COSTCO.

From 50 West

Turn right at intersection with 395 (towards Gardnerville). First right (one block, at light) onto Clear Creek Rd.

From South on 395

Turn left onto Clear Creek Rd. at Bodine's Casino, one block before intersection with 50 West (Lake Tahoe Exit).

From North on I-580/US395 S (Freeway)

Turn left onto S. Carson St. at intersection with Hwy. 50 W. First right (one block, at light) onto Clear Creek Rd.
